  - Increase 7% annually














### **Multiple Award Count**

#### Award Leakage at IVC


Leakage counted only if student has not yet earned degree/cert

# Under new funding formula, IVC would be leaving behind at least <u>\$670,000</u>!



- #1 IGETC and #3 CSU Breadth makes sense (GE certificates)
- #2, #4, #5, and #6 are four of six "Associate in Arts Degrees with an Area of Emphasis" (generic AA's)

### Within 2 Courses (Single Award)

#### Award Leakage at IVC

Leakage counted only if student has not yet earned degree/cert



### Limitations of Analysis

#### This is not a formal award audit!

Analysis is best estimate and potentially:

-Underestimates awards

- 1. Only based on current 2018-19 IVC Catalog
- 2. Does not include qualifying courses from other districts
- 3. Does not count all equivalent courses at Saddleback (if prefix and number differ)

#### -Overestimates awards

- 1. Does not account for variable unit courses (counts courses, not units)
- 2. Does not include IGETC foreign language requirement (HS counts)
- 3. Does not include multiple award limitation (12 unit difference)
- 4. Students might opt-out of award conferral

*Note:* A&R *is spot-checking analysis for accuracy* 

### **Current Band-Aid**



Targeted Outreach via email based on list

- Summer 2018: 30 (11%) of 273 students applied for certificate
- Fall 2018: 56 (22%) of 258 students applied for certificate
- Spring 2019: 277 (30%) of 916 students applied for certificate/degree

#### Limitations

- Students receive hypothetical email (... you might be close to achieving an award ...) based on partially vetted list.
- Time constraints

### Solution at Scale




# Move to opt-out and automatic award conferral

Survey of other CCCs (N=35)

- 4 CCCs auto-award Degrees (11%)
- 12 CCCs auto-award Certificates (34%)





Note: Students still need to apply for awards if they complete courses outside the district

### Legality

5 CA ADC § 55063 Minimum Requirements for the Associate Degree

The governing board of a community college district shall confer the associate degree upon a student who has demonstrated competence [...] completed at least 60 semester units [... and] course work [..] which falls into the categories described in section 55062.

### **Financial Aid**

#### Federal Financial Aid Policy:

[...] you may receive federal financial aid until you exceed 150% of the published length of an eligible program in which the student is enrolled. [for AA degree = 90 units]

#### Internal IVC Policy:

Students who have exceeded the maximum timeframe for a certificate or degree program, or graduated from an associate's or higher degree program will automatically be placed on financial aid suspension.

Students may appeal their SAP suspension by submitting an appeal form with a personal statement, financial aid academic plan (MAP)

### **Priority Enrollment**

#### § 58108. Registration and Enrollment Procedures.

[...]

(c) Districts adopting policies and procedures that include the administration of a registration system that grants priority enrollment to certain students, shall grant registration priority in that system, for each term the registration priority system is administered, to students who:

(1) are first time students within the meaning of section 55530(c) and have completed orientation, assessment, and developed student education plans; or

(2) are not first time students within the meaning of section 55530(c) and have not lost registration priority pursuant to subdivision (h).

(3) who are continuing students not on academic or progress probation for two consecutive terms as defined in section 55031 and first time students who have completed orientation, assessment, and developed student education plans.

#### [...]

(h) Registration priority specified in subdivision (c) of this section shall be lost at the first registration opportunity after a student:

(1) is placed on academic or progress probation or any combination thereof as defined in section 55031 for two consecutive terms; or

(2) has earned one hundred (100) or more degree-applicable semester or quarter equivalent units at the district.


### Senate Bill 478

- (1) Identify those students who have completed an associate degree for transfer.
- (2) Notify those students of their completion of the associate degree for transfer requirements.
- (3) Automatically award the student with the associate degree for transfer.
- (4c) A student may affirmatively exercise an option to not receive an associate degree for transfer or to be included in the identification system described in subdivision

Governor Brown vetoed Bill

- Would have only applied in specific years
- Encouraged CCCs to upgrade their systems and processes "in total"

### Award Inflation?



sketchplanations

- No, not creating new degrees/certificates or making existing ones easier.
- Just trying to better measure/count award completions



### **Student Voices**

23% of 905 students responded (Spring 2019)

-Students that Applied from Outreach Email

- •81% applied for more than one award
- •46% applied for additional awards beyond program of study
- •69% would not have applied if not were for email


-Students that Did Not Apply from Outreach Email

- •14% claimed did not receive notification email
- •16% did not have time to apply
- •23% still plan to take courses after term

### **Student Voices**

#### 93% of students are OK with auto-award

- "The automatic award would actually be appreciated."
- "I think this is a great idea because the majority of the students do not know that you had to apply for a degree/certificate"
- "As long as I get email notification"
- Allowed to take additional classes? Continue school?
- Consequences?
- Option to decline
- Lose sponsorship?
- "I fear the automation may affect someone's transferring or scholarship opportunities. Something that they applied for before the automation of the degree, which would get them denied."
- "My only concern is the system missing a degree that I qualify for"



## How to replicate locally? bit.ly/award-leakage-code

### Award Requirements

#### **Certificates**

- Major (course) requirements
- Cumulative GPA >= 2.0

#### Associate Degrees

- Major (course) requirements
- Cumulative GPA >= 2.0
- Cumulative units earned (*degree-applicable*) >= 60
- General Ed: IGETC, CSU GE, or native/local college GE

#### Associate Degrees for Transfer

- Major (course) requirements
- Cumulative GPA (CSU-transferrable) >= 2.0
- Cumulative units earned (CSU-transferrable) >= 60
- General Ed: IGETC or CSU GE

### **Data Elements Required**

#### <u>Student</u>

- Cumulative GPA
- Cumulative units earned (degree-applicable)
- Cumulative units earned (CSU-transferrable)
- General Ed flag (one of the following)
  - Flag for IGETC completion
  - Flag for CSU GE completion
  - Flag for native/local GE completion
- Completion of major requirements flag

With these data elements, one could determine if a student qualifies for an award.




